# Syllabus for Certificate Course in Vaginal Surgery

#### **OBJECTIVE:**

The candidate could be clinically competent in **Vaginal Surgery**. They would be involved in basic and applied investigation in vaginal surgeries and would be able to provide a consultancy service to other Obstetricians/ Gynecologists. They would have a working understanding of modern methods of all surgeries.

## **SYLLABUS:**

(1) To evaluate exam, investigate and counsel patients for vaginal surgeries.

(2) Expertise in techniques related to the diagnosis and treatment of gynaeproblems; including base line transvaginal sonography and colposcopy.

(3) Experience in open and minimal access surgery.

### Expectations at the end of the course:

The trainee should be able to:-

1. Take an appropriate history and examine the woman;

2. Evaluate, describe, diagnosis and plan therapy for: focus on prolapse and complex benign gynecologic problems. Fellows participate in procedures that include: Hysterectomy include Bilateral salpingo-oophorectomy, modified McCall culdoplasty for vaginal vault prolapse, Anterior and posterior colporrhaphy, Repair of genitourinary injuries including fistula, Repair of rectovaginal, vesicovaginal and urethrovaginal fistulas, A variety of plastic surgery procedures, including McIndoe procedures for creation of, a neovagina as well as various rotational flaps for surgery, Vaginal myomectomy, Tubectomy & Ectopic Pregnancy through Vaginal route.

3. Ultrasound skills: The trainee should be competent in:- appearance of normal and abnormal uterus including fibroids. Endometrial assessment including normal cyclical changes, changes associated with hormone replacement, hyperplasia and malignancy; assessment of ovarian, parovarian and tubal masses; diagnosis of ectopic pregnancy.

4. Understand the risks and limitations of procedures; diagnosis and evaluation of diagnostic procedures; understanding the validity of diagnostic tests, variability and reliability ;criteria; understand the need for clinical record keeping and data storage including use of photography.

# **Ethical and Legal Aspects**

#### Objective

The trainee should be able to discuss the ethical and legal aspects of the clinical practice of their subspecialty and should have particular knowledge of the relevant areas listed below:-

- 1. Legislation, particularly recent, relevant to their subspecialty practice;
- 2. Ethics of health care provision and resource allocation
- 3. Medical confidentiality;
- 4. Consent

Assessment for certification

Internal assessment

Will be based on the evaluation of the log book. Log book- maintaining a proper record of events of teaching and experiences that the candidate has obtained in a log book. The record will include academic activities as well as the presentations and procedures carried out by the candidate.

The written assessment:

There shall be a written assessment at the end .Theory paper shall carry 100 marks.

Practical Exam:

There shall be one external examiner, appointed by the ICOG ~ FOGSI. 1 hour maximum 100 marks

#### Certification:

Based on the recommendations made by the examiners, successful candidate would be awarded the Certificate scroll by ICOG ~ FOGSI.

In case of unsatisfactory completion, the trainee would be given another chance to appear before the examiners (6 months) later.
